# **Superintendent calls for cooperation**

Working together, being aware of all his team is doing were key points of his report

Mike Lach has taken advantage of the superintendent report agenda item at Hinsdale High School District 86 Board meetings to focus on the goals he wants to accomplish and the progress being made. The Nov. 21 board meeting was no exception.

One of this themes was working together.

<sup>a</sup>We are a better community when we work together," he said before announcing the formation of a small parent-student curriculum committee.

"We'll keep growing this committee as we need to," he said. "We want to be able to hear from parents and community members in a variety of ways."

He also plans to recruit more individuals to serve on the Parent-Teacher Advisory Committee, which reviews things like the student handbook, student discipline and attendance.

"We need voices. We need parents. We need people to come help us review that information, think through the policies we have in place, figure out ways to get better," Lach said. "Please think about being a part of it."

He also encouraged stakeholders to put aside conflicting interests to work for the collective good.

"I came to Hinsdale because I believe this place has the foundation to be the best school district in the state, and I can't do it by myself," he said. "This board is working really hard to do it. They can't do it by themselves. This is something we all have to do together."

Finally, he and administrators presented a list of 30 projects under way in an effort to be accountable to all constituents.

"Remember, things always look different in the rear-view mirror," he said. "This is a lot right now, but when we look back, we'll see that change."



# D181 sets plan for hiring its next leader

### Board members reject deputy supt. option, expect to name Garcia's successor by early 2026

The Community Consolidated Elementary District 181 Board intends to hire a new top superintendent in late 2025 or early 2026 to replace Hector Garcia, who will retire at the end of the 2025-26 school year.

At their Nov. 18 regular meeting, board members unanimously approved a succession timeline for the superintendent's post, which calls for the search process to begin next fall and the new superintendent to start work July of 2026.

The decision came after a discussion of two succession plan options in collaboration with BWP & Associates, the firm the board hired last month to lead the search process. Under the traditional timeline approved, focus group sessions with local stakeholders will be held early next year to inform the candidate description when the position is posted next fall. Candidates will be identified and presented for board evaluation before a final selection is made in the winter of 2026. He or she will start the following summer, and Garcia will remain with the district for an additional 30 days to help with the transition.

A second option explored would have significantly accelerated the timeline. Under that approach, candidates would have needed to be identified in the next few months and a final selection made in the first few months of next year in order to have that person serve as deputy superintendent to shadow Garcia for a year beginning next summer.

That additional one-year position would carry an estimated \$200,000 salary.

Most board members favored the traditional approach for several reasons. Asim Aleem feared that top candidates might shy away from the yearlong apprenticeship.

"I think we could get the most qualified candidate to lead the district without the concern that they may view it as a step down or may not want to wait a year to take the reins," Aleem said.

Grace Shin agreed.

"I think that we can recruit the best out there just based off of our merits right now," she said. "I don't necessarily know that we would need to go the deputy route."

Some expressed resistance to expending an estimated \$200,000 for a deputy superintendent on top of Garcia's salary.

Meg Cooper said 30 days of collaboration between Garcia his successor was sufficient. "That gives a lot of transition time," she said, noting the traditional approach also allows the district to leverage the focus groups.

Margie Kleber, who was also a member of the board when Garcia was hired eight years ago, said the district has had success with the traditional approach.

"Clearly you transitioned very well," Kleber said to Garcia. "I would expect that our next superintendent would be, at the very least, as qualified as you are and as capable of transitioning to the role as quickly as you did."

Michael Martin, who is stepping

down after his tern expires in April, voiced support for the deputy superintendent idea.

"I think it would actually expand your pool of candidates," Martin said. "I will leave this decision to the next board, and I hope that the next superintendent can say that they can sniff what Dr. Garcia has done since I've been on the board.

Board President Bill Cotter said BWP was engaged now in order to both begin publicizing the impending superintendent opening and start laying the groundwork for focus groups in early 2025. He asserted that the traditional approach allowed that work to be done in full, unlike the accelerated option.

"We would need to hit the ground running, kind of, tomorrow and try to scramble to do some stakeholder engagement, get the job posted, develop the candidate profile," said Cotter of the deputy superintendent option. "(The traditional approach) does allow us to take our time to have a great deal of clarity around the type of person that we want to hire."

### South teen arrested for having loaded gun



# Couple helps advance Hinsdale agency's legacy

The Community House was where Hinsdale native Dana Reko learned about etiquette, gathered for Girl Scout Troop activities and, most formatively, took fortnightly dance class as a middle schooler.

"I haven't used ballroom dancing since," she admitted with a laugh.

Having now settled in Hinsdale with her own family, Dana appreciates the nonprofit center's services in a way she never did as a youth.

"Our kids, from when they were little, started Tiny Toes music classes there," said the mom of son Charlie, 9, and Kate, 7. "We've had a birthday party there, (Kate's) doing a Stage Door performance, 'Charlie and The Chocolate Factory,' right now. They both do Jodie Harrison Basketball there."

"It appeals to infants and toddlers all the way up to seniors," Dana said.

In response to such personal enrichment, Dana and husband Ryan are serving as co-chairs of The Community House Holiday Ball Dec. 7 at the facility. They are joined in leading this annual fundraiser by fellow co-chairs and Monroe School parents Maureen and Chris Kunitz and Ian and Susie Thorpe. The familiarity with the other couples made their decision to step up a no-brainer.

"It was an easy 'yes'," Dana said. "There's a comfort level among us."

Planning began in late spring and the co-chairs were assisted by a committee of experienced ball handlers. "They're a well-oiled

machine," Dana said. "They've done this for many years."

Ryan said the job has revealed to him just how wide the agency's reach is.

"There are a lot of folks in neighboring towns who participate in Community House programs or will go there for certain events," Ryan said. "It's a pretty broad geographic range that they pull from and very welcoming to anyone that anyone wants to participate."


"It's really just the community getting together to have a good time and celebrate everything good that's happened during the year," he said. What about Dana's junior high dancing dreams?

### KEVIN KUSKA, ACTOR, VOICE TEACHER & MUSIC DIRECTOR

# What is a swing actor?

At any moment during the run of "Cinderella" at Marriott Theatre in Lincolnshire, Kevin Kuska may be called upon to step into the role of chef or king — or summoned to spread a special message from the prince.

"I will step into any of those three roles with as little as maybe an hour's notice," said Kuska, a swing actor in the current production of Rodgers & Hammerstein's "Cinderella", playing now through Dec. 29.

Should an actor playing any of the three roles twist an ankle, fall ill or have a family emergency, Kuska is ready to take their place, having learned the lines, blocking, songs and choreography for the chef, the king and the herald.

That's not to suggest that Kuska is spending his time waiting for a call to the stage. He has many other shoes to fill and hats to wear, including those of stage manager, musical director and private voice teacher at BAM Theatre in Hinsdale. In those roles he organizes the theater program's private lesson schedule and curates master classes led by leaders of the theater world.

"We've had people from Broadway," including an actress who played the role of Elpheba in "Wicked," Kuska said. "She came and gave an incredible two-hour class for us."

Kuska also manages BAM's conservatory program, which meets every Sunday to prepare for competitions all over the country.

Teaching voice was once something Kuska considered his "survival job," but Kuska Studio, where he teaches adult singers and coaches Chicago theater professionals, has become much more than something to do between shows, Kuska said.

Kuska's relationship with musical theater began in seventh grade, when the director of his church choir suggested he audition for a production of "Little Mermaid the Musical."

"I didn't really love it," he said. It wasn't until he was cast in "Legally Blonde" a few years later

that the performance bug bit. From then on, Kuska said, musical theater was all he wanted to do. "I went to college specifically to train in musical theater performance," said Kuska, who graduated from Millikin University in Decatur with a degree in musical theater and a minor in dance. He's now pursuing a master's degree in musical theater vocal pedagogy.

As a backup to the regular cast of "Cinderella," Kuska attends at least a couple of shows each week to keep up on the roles he may be asked to play. Filling the role of swing isn't new for Kuska.

"This is my fourth swing show this calendar year," said Kuska, and while he prefers to have a single role, he has come to appreciate the importance of swings.


"Without them, shows would be canceled every single day," he said. "It works your brain in a better

way. I think it makes you a better performer and a better person," he said. "I learned I was capable of much more than I thought I was."

Kuska said he's grateful for the many people who encouraged him to pursue his dream, and for everyone who supports the theater in one way or another.

"Give back how you can, because theater really can change a student's life," he said. "Everyone needs a place to go, and sometimes the theater is just the perfect place."

# Next week is the last week for village's free fall leaf collection

The village's fall leaf collection program will continue through Thursday, Dec. 5.

The village annually conducts a fall leaf pickup program to keep streets cleaner and safer and to help keep leaves out of sewers and storm drains.

The most important thing to remember is that leaves cannot be placed in the street for removal.

Residents will receive free, unlimited weekly curbside collection of leaves in kraft paper yard waste bags. Bags may not exceed 34 gallons or 60 pounds. Plastic bags will not be picked up.

Bagged leaves should be placed in the parkway in front of the home, along the curb, by 6 a.m. on the scheduled pick-up day. Bags should not be placed in the street.

The village's waster hauler, Republic


Services, will pick up leaves at the time of the regularly-scheduled weekly yard waste pickup. While leaf pick-up is complimentary, all other yard waste will require a yard waste sticker.

In some cases, due to volume, collection may run behind (i.e. Monday collection being completed on Tuesday); however, every household will receive one collection in each of the six weeks.

Residents also may choose to keep their leaves on their property to be composted for use as mulch. The village forester highly recommends the use of compost for keeping plants and trees healthy.



# **Red Devils fire up the giving spirit**

Student-sponsored food drive exceeds goal thanks to school community's generosity

The November wind had a bite to it Friday afternoon in the parking lot of Hinsdale Central High School. But the warm soul of service wouldn't be chilled as students "stuffed the trucks" with essential food and other items in an effort to provide neighbors in need with a happy and healthy holiday season.

The Thanksgiving food drive, jointly organized by the school's National Honor Society and Business Professionals of America club, benefited FISH food pantry of Downers Grove.

"The people who came here from the food pantry were saying that there were a lot of families in need," said senior and NHS board member Kendall Florence while helping direct donors in loading the pantry's truck.

She said word of the one-day

event was spread through email and flyers and within each academic department. Incentives were offered to encourage maximum generosity.

"Departments had a contest to see which class could collect the most donations," Florence said.

Service is a central part of the NHS ethos, and juniors interested in joining could accrue points toward membership by participating in the drive.

Hinsdale's Theresa McClear, recently appointed a Downers Grove Township trustee, was instrumental in connecting the food pantry with the school when she was made aware of the acute need.

"The lines at the pantry are long and the shelves are running low," McClear said, adding they it serves as more than just a food dispensary. "Food pantries benefit the community in many ways. Not only do they reduce food insecurity and provide nutritional substances, food pantries also reduce crime and allow low-income households to pay other essential bills such as home, car and gas."

Lisa Rasin, co-manager of the food pantry, was ecstatic for the support from the Central community.

"This is unbelievable. I'm very appreciative of Theresa and the teachers and counselors that got this together," she said.

She also spoke to the ever-growing demand for pantry assistance,

"We're open twice a week and we're close to (serving) 130 families in a two-hour span each day looking for food," she said. "Five years ago when I started, we had maybe 20 or 25 families a week."

The truck continued to fill with items like mashed potatoes, oatmeal, chicken noodle soup, baked beans, maple syrup and much more as students ran up with contributions to the cause. Carts were employed to ferry donations from inside the school.

The goal was to fill one vehicle. Following the event, McClear sent an final tally.







# Teams thankful to start their seasons

#### **Boys hockey**

**First game:** Sept. 15 vs. Cobras (V won 6-2)

Head coach: Jim Brooks Seasons as head coach: 1st season as head coach, eight years coaching elsewhere

**No. team members:** 19 skaters, 2 goalies

**Strengths:** We've got a lot of talent and the kids definitely work hard, that's for sure.

**Challenges:** I think the biggest thing is just being new this year and every-body learning new systems. Just getting everybody on the same page with a system they've haven't run before has been our biggest challenge. We're working on consistency. When we do it right, it looks really good. The challenge is to do it right all the time.

Who to watch: Our captain, Jack Crabb, is one of the best players in the state. He's incredibly fast and just a gifted hockey player. Dennis Nikolaev is a junior. If he's not leading the league in scoring, he's right at the top. Finn Hamman is one of our defensemen. He's also incredibly strong and explosively fast. **Outlook:** We're kind of at the midway point right now. We've been up and down. We're really hoping that coming out of Thanksgiving break we'll be off to the races. The goal is to win the Illinois West Hockey League.

#### **Boys wrestling**

**First meet:** Nov. 26 vs. Naperville North


**Last year:** 8-14 **Head coach:** Conrad Polz

Seasons as head coach: 1st as boys varsity head coach, third year coaching at Central, head coach at Bolingbrook High School one year, also coached in Tennessee

**No. team members:** 60 in program, varsity limited to 14 weight classes

**Strengths:** The boys who are here are working really hard. I'm really liking their work ethic, their attention to detail. They're asking questions and trying to get better. That's been great. We had our Red-White scrimmage on Friday. I was happy with the way the boys competed. It sets the tone, hopefully, for a positive start to the season.

**Challenges:** Right now we're pretty young, and so really my focus this year is to build a positive and committed culture, to really pay attention to little things and get the kids to buy in. It would be nice to have a few more boys. We might have a couple of weights we're not





able to fill.

Who to watch: Senior Zach Kruse, he'll be at 190 pounds. I'm looking forward to a positive season from him. We also have a junior, Jonathan Martinez, who will be at either 132 or 138. We have another junior, Logan Barrios, who probably will be at 144 pounds. He's a returning varsity guy. We're looking for him to have a positive season as well. We have a freshman, Luke Zajicek, who will be at 215. It's hard to come in that big as a freshman, but we're optimistic he's going to have a strong season, too.

**Outlook:** We might take a few lumps here and there as a team. We're really focusing on getting that positive culture and focusing on some of those individuals and gearing them up for a positive season.

#### **Girls wrestling**

No. team members: 6 Strengths: They want to learn the sport, the technical aspects of it. There's a lot of technique that goes into wrestling. They seem eager to learn certain techniques.

Challenges: We only have six on the roster, so going in against dual meets will be tough. It's a long season when it comes to competitions with dual meets and tournaments. This year we have a little tougher schedule, so they get exposed to a little tougher competition. We practice a lot in the morning. That's a challenge getting up early. Whether it comes to diet, sleep, mental health, rest, you have to factor in all those elements to be successful in wrestling. I'm trying to teach all those elements when they have a tough academic load. It's a new sport. It's going to take time to build a program. It's not going to happen overnight.

**Outlook:** I think it will be an up and down season. There are a lot of programs that are in the same boat as us. At the conference meeting, there were school that have 30 (wrestlers) and schools that have six and everything in between. Hopefully we improve each week and get ready for regionals in February.

**Furthermore:** I've coached college wrestling. I've coach boys wrestling for 20 years. At Hinsdale Central, I've had 34 state qualifiers, 23 state placers, 10 guys in IHSA finals, three state champions, two regional titles and one conference title. I'm trying to teach the girls a lot of stuff I did in the boys program. This is not at that level yet. Hopefully in the future it can get to that level.
